The presiding judge announced the following

Order:

Pursuant to Section 128 a ZPO, participation by way of video conference is permitted.

The presiding judge points out that

Sound and film or video recordings as well as recordings of the (videohearing are prohibited by law pursuant to Section 128a (6) ZPO in conjunction with Section 99 (1) PatG and Section 169 (1) GVG, and the login data for the hearing may not be forwarded or disclosed to third parties.

The possibility of an amicable settlement of the legal dispute is discussed with the party representatives and representatives of the intervening party. An agreement cannot be reached.

The value in dispute is discussed with the representatives of the parties and the representatives of the intervening party. They unanimously state the value at EUR 30,000,000 and apply for it to be set accordingly.

The presiding judge announced the following

Order

The amount in dispute is set at EUR 30,000,000.

b. u. v. (decided and announced)

The party representatives and representatives of the intervening party are given the word to present and justify their requests.

The plaintiffs' representatives of the plaintiffs re 1 to 4 unanimously apply,

declare the European **patent** 1 893 196 invalid with effect for the territory of the Federal Republic of Germany and declare the supplementary **protection certificate** 12 2013 000 155 invalid.

v. u. g. (repeated and approved)

The representatives of the defendant and the intervening party request that

the claims be dismissed.

v. u. g. (repeated and approved)

The presiding judge introduces the facts of the case and the dispute.

The factual and legal situation is discussed with the representatives of the parties and the representatives of the intervening party.

At 11.25 a.m., the minutes are transferred to the legal assessor.

The presiding judge closed the hearing at 2.32 p.m.

After the court has deliberated, the presiding judge announces the following

Judgement :

- I. The claims are dismissed.
- II. The plaintiffs re 1 to 4 shall each bear 25 % of the costs of the legal dispute, including the costs incurred by the intervening party.
- III. The judgment is provisionally enforceable against the provision of security amounting to 120% of the amount to be enforced in each case.
